First Women's Organization in Dallas


Founded in 1934 by four Idlewild Debutantes, Slipper Club was the first women's organization in Dallas. Slipper Club offers a unique network of friendship and opportunities for professional women throughout Dallas. In 1995, Slipper Club expanded its mission to include community service, a charitable giving program, and became a 501(c)(3) non-profit organization. Today, with more than 300 members, the women of Slipper Club are committed to helping lift up our community by serving Dallas-area women and children.

Annual Beneficiary

Each year, Slipper Club researches and selects a charity to serve as the sole beneficiary of their club's fundraising efforts. Members spend the year volunteering and supporting the selected beneficiary culminating in Slipper Club's Annual Gala and Silent Auction & Raffle.

Total Donations

Mission Statement

New Friends New Life (“NFNL”) restores and empowers trafficked and sexually exploited teen girls, women and their children, and drives awareness of the issue and its prevalence. By providing access to education, job training, interim financial assistance, mental health, and spiritual support, New Friends New Life helps women and their children overcome backgrounds of abuse, addiction, poverty, and limited opportunities.

Services

In 2023, NFNL served 320 women and girls by offering comprehensive programming, including:

- **Women’s Program** providing individual/group counseling, case management, and economic empowerment tools to help adult survivors heal and become independent
- A drop-in **Youth Resource Center** helping high-risk, exploited, and trafficked girls ages 12-22 with trauma-informed care.
- **Adult Resource Center (ARC)** provides technology access, computer and life-skills training, and vocational and job readiness preparation opportunities.
- **Employment Partnership Program** helps survivors attain conventional employment, partnering with businesses in North Texas to provide entry-level, livable wage jobs and opportunities for more skill-building.
- **Childcare** while mothers attend educational classes, with capacity to facilitate therapy for young children who have PTSD from experiencing or witnessing abuse and exploitation.

Slipper Club is preparing for the 28th Annual Gala and Silent Auction!

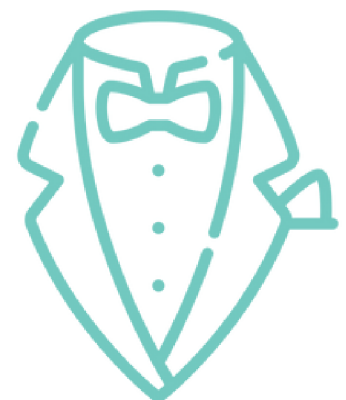

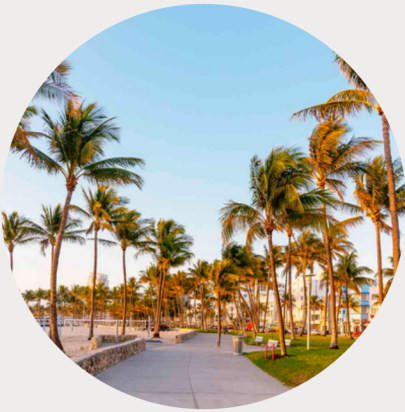
